



at the Council of Europe or collaborators or observers for European organizations), and in addition a spontaneous participation in the construction of the area of justice thanks to original initiatives emanating from the professionals, like in particular the proposal for a creation of the European Coordination Committee for justice in Europe.

In his closing speech, Paul Rochard, vice-president of the French National Chamber of Judicial Officers (CNHJ), indicated that the CNHJ was ready to support the project presented by Jean-Paul Spinelli and to ensure a logistical support and material to him. Mr Rochard thanked all the participants for the very great quality of their interventions as well as the UIHJ, represented by its president, Jacques Isnard, and President Bertaux, to have worked in the realization of this historical event. In fact, it was the first time indeed that a conference, which should be the subject of a publication in the next months, joined together as many actors of the European construction, tending to prove the very great strength of the profession of Judicial Officer on the international level.
